CMS Proposed CY 2021 Home Health Changes

- June 25, 2020
- Would make permanent the reg. changes re: telecommunications tech in providing care under Medicare home health benefit (currently temp for PHE only)
- As long as telecommunications tech is related to skilled services furnished, outlined in care plan & tied to specific goal to facilitate Tx outcomes

CMS May Eliminate Most Emergency Codes for COVID-19 Telehealth Services

CMS is planning to eliminate 74 of the 83 codes created to cover telehealth services during the coronavirus pandemic, though it's adding 13 new codes and could be swayed by public comments to add more coverage.

Other Proposed PFS Changes

- Expand providers who can perform e-visits, remote assessment of patient-recorded video and/or images, virtual check-ins
- Allow direct clinical supervision via TH
- Improve TH frequency limitations for nursing facilities & inpatient
- Significant changes to RPM
- Public comment period ends Oct. 5!
