They are currently co-directors of the federally-funded Southwest Telehealth Resource Center, headquartered here at the University of Arizona. Arizona Telemedicine Program and Southwest Telehealth Resource Center

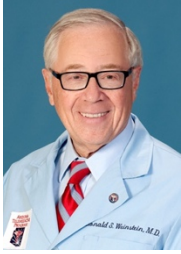

Ronald S. Weinstein, MD, FCAP, FATA, is the founding director of the Arizona Telemedicine Program. Dr. Weinstein is a Massachusetts General Hospital-trained pathologist who is regarded as a pioneer in telemedicine. He rendered his first telemedicine diagnosis, at the MGH in Boston, in April 1968. Dr. Weinstein has served as president of six professional organizations including the American Telemedicine Association where he is President Emeritus. He has received the Distinguished Service Award of the Arizona Medical Association; the Distinguished Service Award of the Association of Pathology Chairs; the Lifetime Achievement Award of the Association for Pathology Informatics; and the Lifetime Teaching Award of the University of Arizona College of Medicine. Dr. Weinstein has been inducted into the United States Distance Learning Association Hall of Fame for innovations in education over telemedicine networks. He has over 300 professional publication including frequently cited papers on both telemedicine and telepathology.
