## Telemedicine and Broadband

OeHI's **Telehealth and Broadband Initiative** develops and supports approaches that lead to increased adoption of telehealth, and reliable and affordable broadband access for health organizations and consumers. Telehealth and broadband are key priorities of the Primavera and Polis administration. Colorado has already made significant progress in providing remote access to care through telemedicine. Telehealth is an important avenue to support health care reform and is increasingly seen as an acceptable alternative to many types of in person provider visits. One of OeHI's Wildly Important Goals, or WIGs, for this year is to increase utilization of telebehavioral health in safety net providers. OeHI is also working to support expansion of telehealth policies and practices based on cost savings, economic impact, and health outcomes.

In Colorado's rural areas, only 7 in 10 people have access to broadband. OeHI's goal, in partnership with other state agencies, is to raise rural broadband availability and pave the path to achieve 100 percent access for all of Colorado. Lack of broadband inhibits the utilization of telehealth services in many parts of rural Colorado as well as the uptake of other emerging health IT capabilities. OeHI is working with the state to expand usage of telemedicine and broadband access in order to make health care across the state more affordable and accessible for all.

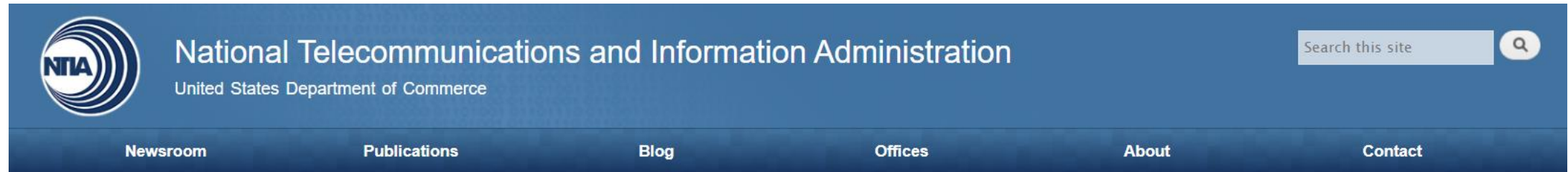

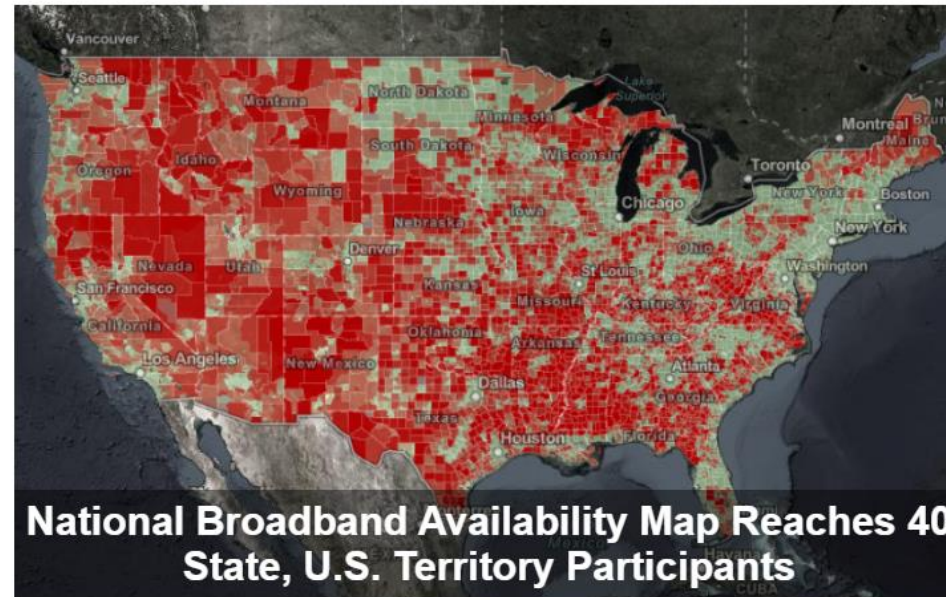

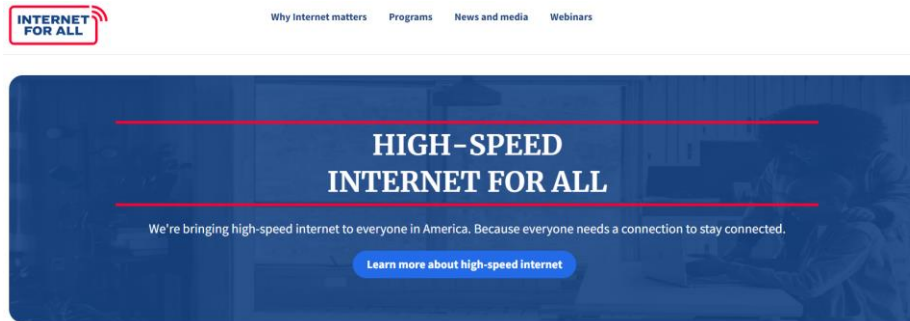

### Overview

President Biden wants to connect everyone in America to affordable, reliable high-speed internet. The Bipartisan Infrastructure Law provides \$65 billion in funding to help achieve that goal. These funds add to and support existing programs that expand internet access and use.

Four agencies are leading this historic effort: the National Telecommunications and Information Administration (NTIA), the Federal Communications Commission (FCC), the Department of the Treasury, and the U.S. Department of Agriculture (USDA).

Programs support high-speed internet planning, infrastructure, and adoption. We define these terms as follows:

- **Planning:** Data collection, mapping, and feasibility studies to help develop internet expansion projects.
- **Infrastructure:** Infrastructure for high-speed internet deployment.
- **Adoption:** Activities that ensure users can access and meaningfully use high-speed internet. Includes subsidies, equipment, public access, digital literacy, skills training, workforce development, telehealth, and remote learning.

The goal of these programs is to achieve digital equity through improved access and intentional, inclusive planning that leads to effective, impactful outcomes. Because everyone in America should have access to reliable and affordable high-speed internet.

## Grants

NTIA administers grant programs that further the deployment and use of broadband and other technologies in America, laying the groundwork for sustainable economic growth; improved education, public safety, and health care; and the advancement of other national priorities.

### Infrastructure Investment and Jobs Act Overview

On November 15, 2021, President Biden signed the **Infrastructure Investment and Jobs Act** into law. This Act includes a significant investment of \$65 billion to help close the digital divide and ensure that all Americans have access to reliable, high speed, and affordable broadband. This investment builds upon the funding for broadband deployment provided in the American Rescue Plan, the Consolidated Appropriations Act, 2021, the FCC's Universal Service program, and USDA's Rural Utilities Service broadband programs. This historic investment will lay critical groundwork for widespread access and affordability of broadband, creating new jobs and economic opportunities, providing increased access to healthcare services, enriching educational experiences of students, and improving overall quality of life for all Americans.

#### Oct. 13, 2022 PHE Waiver Extension

#### Nov. 12, 2022 White House Notification of PHE End

Providers may be worried  
this means the end of  
telemedicine-remind them  
of the 151-day extension!

#### December 2022 CMS Releases PFS CY23 Final

Providers unsure if this means  
telehealth is still permissible in  
the home for Medicare pts.  
*Send a memo!*

#### Jan. 1, 2023 PFS CY23 Effective

What does this mean?  
*Reassure providers that home is  
a Medicare-covered service  
under the waiver AND of the  
151-day extension. Give them  
a heads up about any  
modifiers or workflow changes.*

#### Jan. 11, 2023 PHE ends – 151-Day Flexibilities Begin

Reassure providers that  
nothing changes right now  
except perhaps their video  
platform. *Double check your  
allowable Medicare provider  
types.*  
*Here is a handy grid.*

#### Jan. 11, 2023 HIPAA Waiver Ends

Providers must use HIPAA  
secure, BAA covered video  
platforms and patient  
communication.

#### June 2023 151-Day Flexibilities End

PFS CY23 rules now apply  
but *some PHE codes remain  
in effect.*  
*Check the CMS list*

#### Dec. 31, 2023

Last remaining telehealth  
waiver codes expire. PFS  
CY24 goes live tomorrow.
