Dr. John Molina is Pascua Yaqui and Yavapai Apache. He is the Director of the Arizona Advisory Council on Indian Health Care. His interests are in the alignment of Indigenous Medicine and Western Medicine, and Indian Health Care Law and Policy. Dr. Molina has held positions as Compliance Officer and Health Systems Director for Native Health Urban Indian Clinic (Phoenix, AZ); Health Systems Director for the Kenaitze Indian Tribe (Kenai, AK); Chief Executive Officer for Phoenix Indian Medical Center; and Assistant Director and Medical Director for the Arizona Health Care Cost Containment System (AHCCCS). He practiced as an OB/GYN physician with the Indian Health Service and Las Fuentes Health Clinic, which he founded in his hometown of Guadalupe, Arizona. He is a U.S. Navy veteran.
